Various Modes of QuickBooks Hosting


Dedicated Hosting:

Here, different users are connected to the QuickBooks-installed server. The QuickBooks Hosting Mode on the server is set to "Enabled" and "Disabled" on workstations.

Dedicated Hosting method:-

- No User use QuickBooks here




Various Modes of QuickBooks Hosting

Peer-to-Peer Hosting:

This type of hosting allows one user to host the application and data to provide access to other users on the network. Here, the host sets the QuickBooks Hosting Mode as "Enabled" and "Disabled" on the workstations.



Alternate Hosting:

Here, the primary user is connected to the hosting server via the internet. Other users on the network must communicate with the primary user to access the cloud-hosted QuickBooks. You need to set the QuickBooks Hosting Mode as "Enabled" on the host and "Disabled" on workstations.




